MATTER BEFORE THE PLANNING COMMISSION:

Preliminary Plat and Final Plan - The Willows Apartments at Grand Park, Planning Area 2W.1 and 2W.2

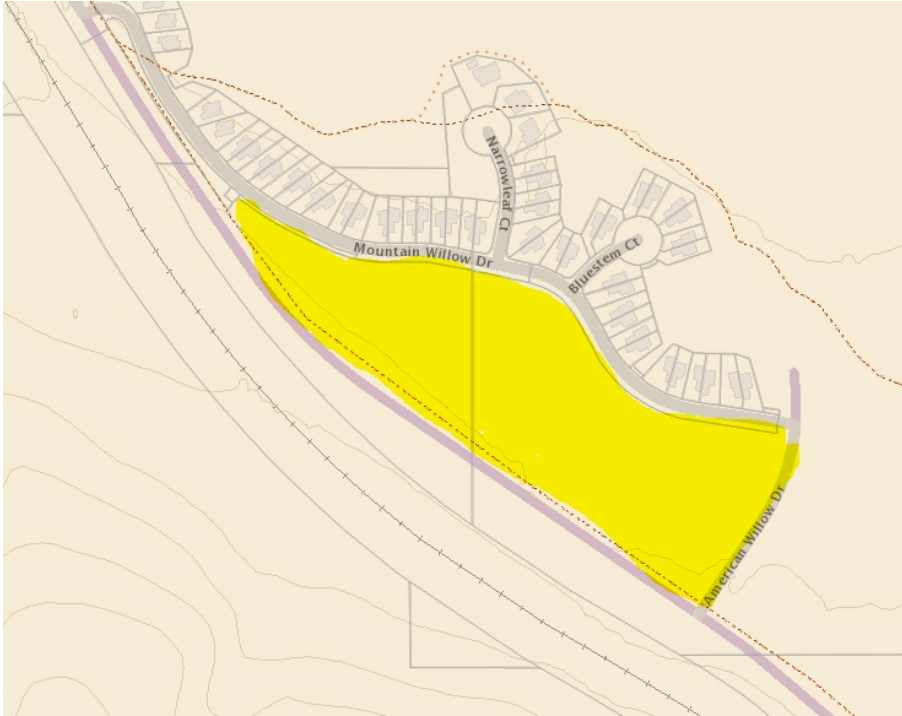
ACTION REQUESTED:

The applicant, Grand Park Development, LLC., is requesting Preliminary Plat and Final Plan approval of The Willows Apartments at Grand Park.

BACKGROUND:

This subdivision application is being processed as a Major Subdivision in accordance with Section 17-5-10 of the Fraser Municipal Code. The purpose of a major subdivision plat is to divide one (1) or more lots or parcels of land into a total of five (5) or more lots or five (5) or more dwelling units.

Map below indicates the general vicinity of this proposed development:



We have confirmed with the applicant that notices were not sent

out to all property owners within 200' of the boundaries of the subject property at least 14 days in advance of the hearing per code below:

Under Section 19-1-215(a) of the Town Code, the Planning Commission has the authority to deny the application or continue the public hearing until the required notice is given. That determination will be made at the May 26, 2021 meeting.

Code §19-1-215(a):

- (a) Notice shall be sent to all property owners within two hundred (200) feet of the boundaries of the subject property at least fourteen (14) days in advance of the hearing. The applicant shall provide this notice, along with evidence it has been satisfied as part of the hearing record.
 - (1) Such notice shall be sent via certified mail, return receipt requested, and shall include the following information: A copy of the application with a plat or drawing depicting the proposal; the name, address and phone number of the authorized contact for the applicant; and the time, date and place of the public hearing.
 - (2) The applicant shall provide the Town with a written affidavit prior to the time of the public hearing reflecting the date of mailings and the names, addresses and legal descriptions of all parties to whom the notifications were transmitted.

- (3) Failure to properly mail the documents, notify the necessary parties and/or provide the required affidavit shall be grounds for denial of the application or a continuance of the public hearing until such notice is provided.

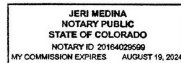
